

## Hazardous Voltage!


Failure to disconnect power and discharge capacitors before servicing could result in death or serious injury.

Disconnect all electric power, including remote disconnects and discharge all motor start/run capacitors before servicing. Follow proper lockout/ tagout procedures to ensure the power cannot be inadvertently energized. Verify with a CAT III or IV voltmeter rated per NFPA 70E that all capacitors have discharged.

- 1. Power off unit.
- Mount LSD1 and LSD2 in control box per diagram below using screws provided.
- 3. Disconnect wire 112A from LPC1 and wire 113A from LPC2. Disconnect wires 114A and 115A for VFD units.
- 4. Connect the following wires:
  - a. W58 to LPC1
  - b. W60 to LPC2
  - c. W57 to wire 112A (114A)
  - d. W59 to wire 113A (115A)
  - e. 104T to LTB1-R
  - f. 101AY to LTB1-B
  - g. 111G to LTB1-Y1
  - h. 110G to LTB1-Y2
- 5. Secure wire harness with provided wire ties.
- 6. Place schematic in a location easily visible inside control box or on the access panel.
