AWARNING




Inspection

1. Check carefully for shipping damage. If any damage is found, report it immediately, and file a claim against the transportation company. Replace damaged parts with authorized parts only.




2. Remove the screws around the unit top panel assembly. Refer to Figure 1.

Figure 1. Remove screws around top panel assembly




3. Rotate the top assembly. Refer to Figure 2.

Figure 2. Rotate top assembly




4. Remove the indoor section access panel. Refer to Figure 3.

5. Remove the screw from the top right hand side corner of the supply panel. Refer to Figure 4.








Figure 6. Switch pigtail connection

6. Locate drain pan below the evaporator coil and place the switch in the slot provided in the overflow bracket. See Figure 6.

Install the drain pan overflow switch using the screw removed in previous step. Refer to Figure 5.

Figure 5. Install drain pan switch


Figure 7. Install relay and timer

8. Install the relay and timer on the left side of the control panel. Refer to Figure 7.




9. Route drain pan overflow switch wiring along the indoor fan deck. Refer to Figure 8 and Figure 9.
