1 Warnings, Cautions, and Notices

Read this manual thoroughly before operating or servicing this unit. Safety advisories appear throughout this manual as required. Your personal safety and the proper operation of this machine depend upon the strict observance of these precautions.

General Information

- Each expansion module has a total of four points that can be configured using any combination of inputs/outputs.

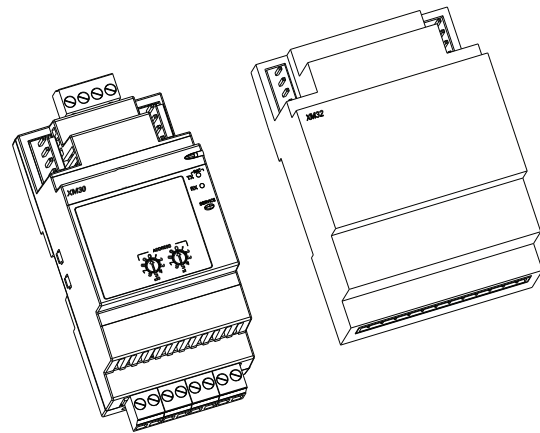

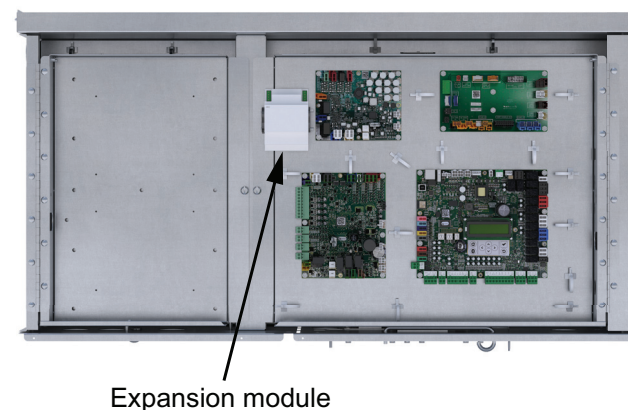
Note: If unit is factory equipped with a LonTalk® communication module, the LonTalk module must be relocated externally to the unit in order to install an expansion module. A NEMA rated enclosure will need to be sourced and used to properly protect the LonTalk module when externally mounted.

6 Installation

Precedent™ - digit 21 = 0 No communication options are enabled

Important: If model number on Precedent unit digit 21=0, no communication options are enabled, the expansion module kit is not licensed or supported for this option. To enable an expansion module kit, the Symbio™ 700 must be replaced through the supply team with a properly licensed Symbio 700.

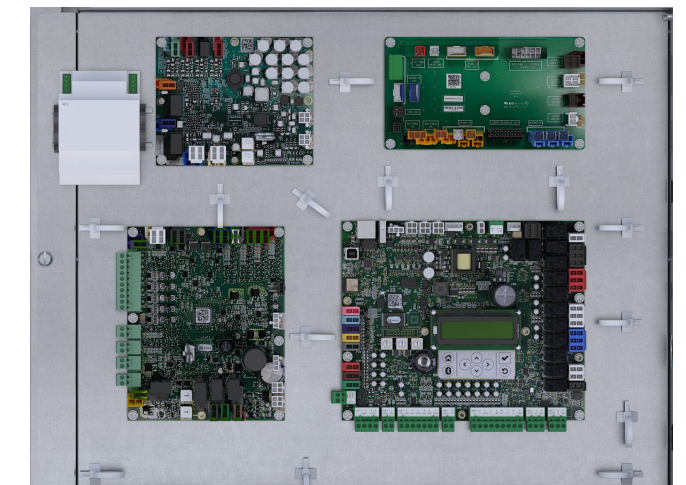
Figure 2. Precedent - expansion module mounting location
