General Information

Important: Start-up instructions are provided only as a convenience. See the operation manual or contact Trane Rental Services with questions.

1. Locate p-trap (inside the unit return air cabinet) and install



Open supply and return plenums and connect supply and return flex duct (if needed) at their plenums.



If needed, connect the remote sensor (inside the return air cabinet) to quick connect and adjust sensor selector switch accordingly (above quick connect on the front of the machine).



4. Wire incoming electrical cable into pin, cam-type connections and outgoing cable to sleeve, cam-type connections. If equipped with and outgoing connections are not to be used, use bar to Lock Out, Tag Out sleeve connections



5. Turn power **ON** at job site breaker or disconnect (not shown).

6. Turn the disconnect switch ON.



On front of machine verify green, power on light is **ON** and red, phase failure LED is **OFF**.



- 8. Turn thermostat system switch to cooling, heating, or cooling/heating.
- 9. Turn fan selector switch to **ON**. Auto is only recommended when remote sensor is in use.

10.Use slider bar to choose heating/cooling set points.

Note: When gas heat is utilized, Trane start-up is required for initial start and run to verify proper operation of heat.



11. To turn machine off, turn system selector switch **OFF**. Allow heating/cooling to cycle off and turn unit disconnect switch **OFF**.
